AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA, APPROVING AND AUTHORIZING THE PROPER CITY OFFICIALS TO EXECUTE A FIFTH AMENDMENT TO THE AGREEMENT FOR POLICE SERVICES BETWEEN THE CITY OF POMPANO BEACH AND THE SHERIFF OF BROWARD COUNTY, FLORIDA; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to law, ten (10) days' notice has been given by publication in a paper of general circulation in the City, notifying the public of this proposed ordinance and of a public hearing in the City Commission Chambers of the City of Pompano Beach; and

WHEREAS, a public hearing before the City Commission was held pursuant to the published notice described above, at which hearing the parties in interest and all other citizens so desiring had an opportunity to be and were, in fact, heard; now, therefore,

BE IT ENACTED BY THE CITY OF POMPANO BEACH, FLORIDA:

SECTION 1. That a Fifth Amendment to the Agreement for Police Services between the City of Pompano Beach and the Sheriff of Broward County, Florida, a copy of which Amendment is attached hereto and incorporated herein by reference as if set forth in full, is hereby approved.

SECTION 2. That the proper City officials are hereby authorized to execute said Amendment.

SECTION 3. If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of

this Ordinance that can be given effect without the invalid provision or application, and to this end the provisions of this Ordinance are declared to be severable.

SECTION 4. This Ordinance shall become effective upon passage.

FIFTH AMENDMENT

TO

AGREEMENT

FOR

POLICE SERVICES

This Fifth Amendment is entered into this 6th day of April, 2022 by and between the Broward Sheriff's Office (hereinafter referred to as "BSO") and the City of Pompano Beach, FL (hereinafter referred to as the "CITY").

WHEREAS, on or about October 15, 2020, BSO and the CITY entered into an Agreement for Police Services; and

WHEREAS, BSO and the CITY entered into a First Amendment to the Agreement for Police Services for the addition of ShotSpotter; and

WHEREAS, BSO and the CITY entered into a Second Amendment to the Agreement to reclassify a vacant CSA position to a crime analyst position; and

WHEREAS, BSO and the CITY entered into a Third Amendment to the Agreement to reclassify a nine SRO positions from Grant funding to the General Fund; and

WHEREAS, BSO and the CITY entered into a Fourth Amendment to the Agreement to reclassify a CSA position to a deputy sheriff position; and

WHEREAS, CITY and BSO are now desirous of adding a deputy sheriff position to the staffing complement; and

NOW, THEREFORE, in consideration of the mutual terms and conditions contained herein, the parties agree as follows:

1. The foregoing recitations are true and correct and are incorporated by reference.
2. Effective April 1, 2022, the staffing complement as reflected on Exhibit A will be modified to add one additional deputy sheriff position.
3. Except as modified herein, all remaining items and conditions of the Agreement, shall remain in full force and effect.
