- If private plans review is elected, the Building Official, pursuant to City policy and §553.791(2), F.S., will require the fee owner or the fee owner’s contractor to use a private provider to also perform all required building inspections for the project.
- I understand the local Building Official may not review the plans submitted or perform the required building inspections to determine compliance with applicable codes, except as allowed by law. Instead, plans review and/or inspections will be performed by licensed or certified personnel identified in the application. I have inquired into their competence and insurance and am satisfied my interests are protected. I agree to indemnify, defend, and hold harmless the City, the Building Official, and code enforcement personnel from claims arising from my use of such personnel.
- I understand the Building Official retains authority to review plans, make required inspections, and enforce applicable codes within his or her charge pursuant to §553.791, F.S.
- If I (or my contractor) change the listed private providers or the services to be provided, I/we will update this Notice **within 1 business day after any change or within 2 business days before the next scheduled inspection**. A change of a duly authorized representative named in the permit application does not require a permit revision, and no fee shall be charged for making the change.

**Note:** Private provider plans review/inspection services are limited to building code compliance; they do not include Fire Prevention, land use, environmental, FEMA regulations, or other local codes.
