G. NEW BUSINESS

 Conveyance of City Owned Property on Dixie Highway from NW 6th Street to NW 8th Street to the Pompano Beach CRA

Nguyen Tran, CRA Director, presented the item to the Committee. He covered many things including but not limited to:

H. DIRECTOR/STAFF REPORT

1. Update on 737 Dr. Martin Luther King, Jr. Boulevard Property

Kim Vazquez, Project Manager reported on the property with the following information:

- The CRA purchased 7 years ago and renovated the property as a "vanilla box" shell
- Request For Proposal was issued for purchase, purchase with option to buy or for lease for owner occupied, viable commercial business
- The CRA Board approved the ranking of West Construction to purchase and occupy the space
- A Sale/Purchase contract will go to the Board at their next meeting of November 19th.
- Some of the provisions in the contract is they must maintain ownership for five (5) years and the CRA will maintain the first right of refusal if the property is placed on the market for sale.
- Financial Report Detail Statement of Activities –September 2019

There was one substantial item including the property acquisition of 11 NE 1st Street for \$1.2M as approved by the Board in 2014. The Committee will review and bring forth any comments next month.

I. KEY PROJECTS

Horacio Danovich, CIP Director and Nguyen Tran, CRA Director reported:

- MLK Boulevard Streetscape and Resurfacing Project is currently moving into Phase 2. Mr. Danovich anticipates the section from 6th Avenue to I95 should break ground in January or February and the section from I95 to Powerline Road will have a final bid by December.
- Innovation District is still in the solicitation process. There won't be any more information until February 5, 2020, when the packages are received they will be reviewed, ranked and brought to the Board.

Phyllis Smith asked **Horacio Danovich** about the traffic light on 27th since there was a loss of life. He reported because of the crash and the fatality we are approximated two weeks from getting those repairs completed and will be ready to complete the project. It will probably be after Thanksgiving before it can be completed. **Mr. Pooler** suggested we push forward and make sure this gets completed as soon as possible. **Mr. Pooler** asked if someone from the County could come and experience that intersection themselves to understand the need for this completion.

- McNair Park Mr. Danovich said there is a long way to go on this project.
 Phyllis Smith asked if this could move faster and the answer was no because of all the moving parts of this project.
- Kensington Town Home Mr. Tran reported the rezoning is complete and now we are waiting for plans to be approved and the permit process to start. Frank Gotsman clarified a few points of this project. He reviewed the timeline of the process thus far and explained the timely process. Whitney Rawls thanked Mr. Gotsman for the update and is glad to hear we are finally at the permitting stage. Shelton Pooler voiced his thoughts that the City is part of the delay in the permits being issued. The Committee encouraged the developer to update them when there are delays moving forward.
- City Vista Co-Working Space the City is reviewing the project and they are looking for a contractor to complete the buildout. Mr. Tran does not foresee this taking much longer.
- Old Town Streetscape will be completed this week.
- Anne Gillis Park Mr. Danovich will be back in December with the budget, but he is expecting it to be approximately \$750,000. Mr. Pooler and others asked why the price has increased and it was discussed.
- Patagonia Project Mr. Tran said the Committee and the Board approved an unsolicited proposal to enter into a development agreement. The agreement has been put on hold on until forward movement has been made on the Kensington Town Home project. Mr. Tran asked the Committee if they want to continue to move forward with a development agreement. The Committee suggested moving forward with the development agreement.
