PROJECT OBJECTIVES

Replace outdated, energy inefficient sodium halide light fixtures with new, greener LED-based units. The City worked to identify two (2) models and styles that can be installed City-wide. The decorative model will be used as much as possible, except when concrete poles cannot be retroffited. The goal is to replace as many units as possible throughout the City as described in the table below.
