

# PUBLIC NOTICE

## City of Pompano Beach Office of Housing and Urban Improvement

In preparation of officially opening the Fiscal Year 2021-2022 Waiting List for the City's Home Improvement Programs the City of Pompano Beach Office of Housing & Urban Improvement will purge its waiting list for all home improvement programs effective December 31, 2021. This is necessary for the following reasons: 1. To determine that the pool of applicants already on the waiting list reasonably represents interested Pompano Beach households, 2. To confirm the households are still eligible and interested in participating under the City's housing programs. Applicants with continued interest must call in to complete a new preliminary application providing all information needed for placement on the waiting list, such as address, phone number, household composition, income, type of preference claimed and minority designation of the head of household.

Below please note the gross income limits for the programs by household size. Households whose income exceed the limits listed below do not qualify for assistance under the home improvement programs. Eligible home improvements will be determined by an inspection of the property.
