The City of Pompano Beach is a HUD entitlement community. As such, the City receives Community Development Block Grant (CDBG) and HOME grant funding that is allocated to local non-profit organizations and City departments that administer public service, housing, public facilities, economic development and infrastructure for our residents. *This year, the City's allocation is \$986,989.00 for CDBG and \$403,897.80 HOME totaling \$1,290,886.80.*
