

POMPANO BEACH AMPHITHEATER SURVEY SWEEPSTAKES RULES ("OFFICIAL RULES")

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

1. SPONSOR INFORMATION: This Survey Sweepstakes (the "Sweepstakes") is sponsored by AEG Presents LLC ("Sponsor"), having its principal place of business at 425 W. 11th Street, Suite 400, Los Angeles, CA 90015. The Sweepstakes entry period begins [date] at or about 10:00 AM Pacific Time and ends on [date] at 11:59 PM Pacific Time (the "Entry Period"). All times are based solely on Sponsor's computer clock.

2. ELIGIBILITY: This Sweepstakes is open to individuals who have reached the age of majority in their state of residence (18 in most states, 19 in Alabama and Nebraska and 21 in Mississippi) and are legal residents of one of the 50 contiguous United States including the District of Columbia (excluding Guam, Puerto Rico, and all other U.S. territories and possessions).
